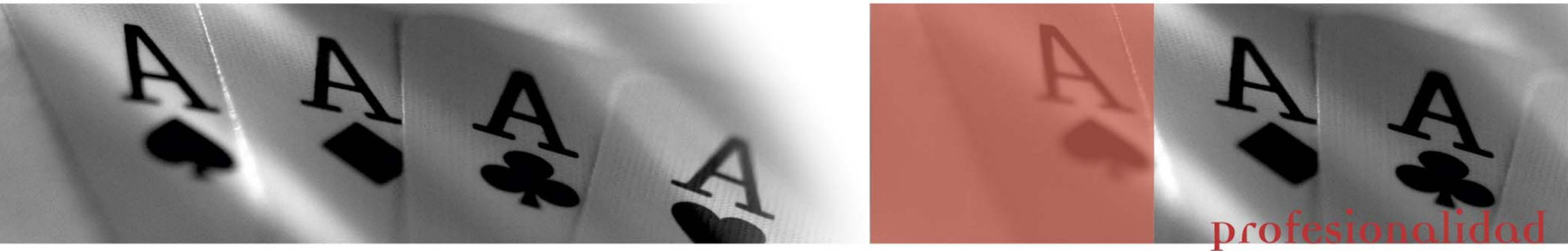

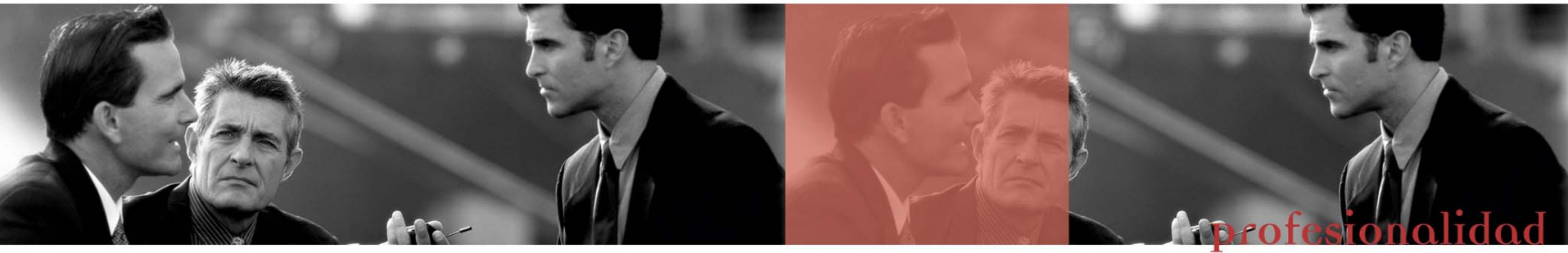
Clientes del Despacho
